OVERVIEW

Priori Capital Management Investment Fund is a New Zealand private investment fund structured as a unit trust. The fund seeks to generate superior long-term risk-adjusted returns through trading across global equities, equity options and non-equity derivatives i.e futures and CFDs.

Priori operates four mirrored quarterly sub-funds to support cashflow tracking, fee calculation and annual liquidity windows while maintaining consistent portfolio exposure across vintages.
